To Darlene Booker-Jones, Chair of the AFSCME Local 696 Election Committee,

My name is J. Matthew Catron. Co-signing this protest with me today is Executive Board candidate Charles Payne, III. I am writing you today to protest the unjust process by which the 2023 AFSCME Local 696 election was conducted. Specifically, I seek to highlight a broken promise on the part of the Election Committee. The candidates of the Rabble Rousers slate were informed on February 27th, 2023 that they would have an opportunity to review the ballots before they were distributed.

They were given no such opportunity. Local 696 members started receiving ballots on March 9th, 2023 much to the surprise of the Rabble Rousers candidates. While this promise was not given in writing, I received an unsigned, anonymous email from "secretary696@aol.com" offering a copy of the ballot for review on March 9th, 2023 that was never actually sent.

One week later, on March 26th, 2023, I received another email from the same account claiming:

To address the issue for review of the ballot, this was due to the timeframes, deadlines and change on ballot presented to AAA were reasons sample ballot did not happen.

The full correspondence is attached to this letter.

By having no opportunity to review the 2023 Election ballots, the Rabble Rousers team had no way to correct potential errors, or even know when the ballots were cleared for distribution. As a result of that deliberate miscommunication, the Rabble Rousers lost valuable time to campaign for themselves. The incumbent slate, the SBU, were given full information as to the preparation and distribution of the ballots even before nominations, and thus had a significant and unfair advantage in the election.

I believe, and my Rabble Rouser colleagues agree, that this one-sided communication was sufficiently disadvantageous to the fairness of the 2023 Local 696 election that it could have impacted the election results.
